#### STANDARD CONDITIONS

This Class A Safety Permit is issued in terms of the National Railway Safety Regulator Act, 2002 (Act 16 of 2002) and is subject to the following conditions:

- 1. The management of railway safety resides with the permit holder and cannot be delegated or transferred.
- 2. Submission of an application for renewal of a safety permit at least 90 days prior to the expiry of the permit.
- 3. Payment of the Annual Safety Permit Fee and Application Fee upon receipt of an invoice from the Regulator.
- 4. Payment of outstanding penalties upon receipt of an invoice from the Regulator.
- 5. Compliance with any special conditions as per the Safety Permit Life Cycle Policy.
- 6. The Operator shall prepare and submit an Annual Safety Improvement Plan (ASIP) to the RSR in accordance with the prescripts of the SMS Determination at least 90 days prior the anniversary date of the issuance of this Permit.
